### **Policy Statement:**


The University of Azad Jammu and Kashmir is committed to minimizing its environmental impact by reducing plastic waste on campus. This includes decreasing reliance on single-use plastics, implementing recycling programs, and encouraging sustainable choices among students, faculty, and staff.

### **Objectives:**

1. **Eliminate Single-Use Plastics:** The University will phase out single-use plastic items, including plastic cutlery, straws, cups, and bags, in favor of reusable or biodegradable alternatives.
2. **Promote Reusable and Biodegradable Options:** The University will encourage the use of reusable products (such as water bottles, containers, and bags) and biodegradable materials to replace disposable plastics on campus.
3. **Recycling and Waste Management:** The University will implement and maintain recycling stations across campus to collect and properly dispose of plastic waste. Clear signage will be provided to educate the campus community on proper recycling practices.
4. **Awareness and Education Campaigns:** The University will organize awareness programs to educate students, faculty, and staff about the environmental impact of plastic waste and how they can contribute to reducing it.
5. **Engagement with Vendors and Suppliers:** The University will require vendors and suppliers operating on campus to minimize plastic packaging and provide sustainable options for food packaging, utensils, and other items.
